NOTICE OF PAYMENT DUE, RIGHT TO REVIEW AND HEARING REQUEST FORM

You must pay the fine **within thirty (30) calendar days** from the date of service (meaning the date of personal service, the date of delivery of the citation by certified mail, or three days following deposit of the citation in the mail, whichever occurs first) or face late payment penalties and an additional citation. Payment may be made by cash, money order or cashier's check payable to the Rincon Band of Luiseño Indians P.O. box 68 Valley Center, CA 92082. Alternatively, if you dispute the citation, the Rincon Peace and Security Code provide you the opportunity to challenge the citation and request a hearing before the Tribal Court. To request a hearing, you must fill in the following information and mail or deliver the completed citation form in its **entirety within (30) calendar days** from the date of service to the Tribal Court's office at the following address 49002 Golsh Rd. Valley Center, CA 92082. Please be advised that, if you seek review, the Tribal Court Judge has the discretion to increase the amount of the fine set out in this citation if warranted and, if he or she finds the hearing request to be completely without merit, to order you to pay costs. Failure to respond to this notice or failure to appear at the requested hearing, for purposes of contesting the citation or offering mitigating evidence, will result in a default judgment against the person in the amount of the citation plus a sanction imposed by the Court for the person's failure to respond or appear. You are encouraged to make and keep a copy of the completed documents for you records. You may request a free copy of the Rincon Peace and Security Code by contacting the Rincon Band of Luiseño Indians at the above address. **A notice of civil infraction represents an official determination that a civil infraction has been committed. This determination is final unless the person contests it in a manner set forth in these Rules.**
